McDermott vs. Perez (In re Perez), Case no. 18-8036, File Name: 19b0008n.06 (December 30, 2019)

The BAP affirms denial of a discharge to a debtor under Section 727(a)(4)(A) who: (i) failed to list an entity or an interest in the entity on his schedules (which entity owned real estate); (ii) failed to list a bank account in his schedules; and (iii) failed to value an entity listed in the schedules. BAP determined that the debtor's failure to accurately fill out the schedules constituted a "false oath or account" under Section 727(a)(4)(A).
