Digital File Requirements

Digital files in PDF format are preferred, however EPS, TIFF and JPG file formats are accepted.

- Files must be high resolution, no less than 300 dpi.
- All fonts must be embedded.
- File must be in grayscale or cmyk image mode.

Deadlines

- Reservation: 6 weeks in advance of issue date
- Art:
 - **November/December** issue: Submissions due no later than October I
 - Jan/Feb issue: Submissions due no later than Dec. I
 - March/April issue: Submissions due no later than Feb. I
 - May/June issue: Submissions due no later than April I
 - July/August issue: Submissions due no later than June 1
 - September/October issue: Submissions due no later than August I
